"A Class Fire Rated Marine Doors" double-leaf hinged fire door with optional window tested and approved as Class A-60 in accordance with Annex 1, Part 3 of the IMO 2010 FTP Code.

Maximum door leaf size for active leaf is 42 1/2 inch width by 90 5/16 inch height; maximum size for inactive leaf is 42 7/16 inch width by 90 5/16 inch height. Active door leaf provided with WSS three point mortise lock, DSM custom stainless steel lift-off hinges, inactive door leaf provided at the top and bottom with manual flush bolts. The active door leaf may include a window with a maximum clear opening of no more than 100 square inches; dimension of 10 inches by 10 inches.

The door frame is to be bolted using Grade  $8\ 1/4$  inch bolts at c/c  $300\ mm$  or stitch or continuous welded to the bulkhead per manufacturer's instructions.

The approval is subject to any conditions noted on this Certificate and in the applicable laws and regulations governing the use of the item on vessels subject to Coast Guard inspection or on other vessels and boats.

Consideration will be given to an extension of this approval provided application is made 3 months prior to the expiration date of this Certificate.

The approval holder is responsible for making sure that the required inspections or tests of materials or devices covered by this approval are carried out during production as prescribed in the applicable regulations.

The approval of the item covered by this certificate is valid only so long as the item is manufactured in conformance with the details of the approved drawings, specifications, or other data referred to. No modification in the approved design, construction, or materials is to be adopted until the modification has been presented for consideration by the Commandant and confirmation received that the proposed alteration is acceptable.
